1. Minutes

The minutes of the last meeting were approved and signed. Any matters arising are covered on the agenda.

2. President's Report

Helen welcomed everyone wishing us a Happy New Year.

She reported two actions: 25 Nov UN Action Violence against Women, orange ribbons were given out in Cockermouth.

A stall was held on Keswick Market for Land Mines action collecting 200 signatures on the petition. Orange ribbons given out here too.

Everyone enjoyed the Christmas Party.

An envelope was passed round for the International President's appeal 2017-2019 for 'Women, Water and Leadership, supporting projects which educate, enable and empower women ensuring they have the capacity, experience and education needed to manage water resources and gain careers in water related professions.' (www.soroptimistinternational.org)

3. Treasurer's Report

3.1 GIFT AID forms: As SIGBI is now a registered charity, the component of the subs you pay, via club, to SIGBI can now be gift aided if you are a tax payer and are eligible. Claire circulated forms to be signed for those wishing to do this and will be in touch with those not attending tonight's meeting. **ACTION:** Claire/ALL

3.2 Current statement at end of Dec

Subs £756.47

Charity account:(all assigned) £1687.14

Admin: £530.09

3.3 Subs Main item for discussion was a proposal, from the Executive, to increase subs. Subs were held last year but need to be increased this year due to increased subs for SI, SIGBI and UKPAC but also because we have increased ongoing costs. We do not have the option to keep the status quo

SIGBI dues are currently £43 and will increase in April to £48 UKPAC and region will increase from £6 to £6.50 Total increase of £5.50pa per member

Currently full members pay £81 from which we receive £32 from each member to club admin funds, the rest going to SIGBI, UKPAC and SI as explained above

Currently link members pay £50 of which £49 goes to SIGBI, region and UKPAC and £1 to club

Once subs are collected and all dues paid, the total income to our admin account is £680 based on 21 full members, 8 link members and 1 honorary member. The total expenditure to our club for 2018-19 year is £949

So the projected deficit is £269 which is not sustainable, although we do have a small 'safety cushion'. Therefore subs have to be increased.

We are not trying to accrue reserves, we are trying to make sure we have a sensible cushion to cover unexpected costs e.g. room rent increase.

The projected 2019-20 figures are based on 20 full members, 8 link, one honorary member.

Min increase proposed is £9 per person per annum, both full and link, bringing subs to £90 pa for full member and £59 for link member

Joan gave worked examples of other possible rises, but the key point is that if the minimum increase is preferred then there will be a further requirement for an increase of about £9 the following year, as this does not offset the deficit.

The minutes of the Nov meeting referred to the point that a decision would be taken at the meeting tonight, so a formal proposal was made.

After much discussion the following proposal was voted on:

To raise the subs by £12 pa for both club and link members, making the annual amount £93 for full member (£7.75 per month from April for those paying by direct debit) £ 62 for link members

Proposed: Claire Rawlinson Seconded: Katherine Eilbeck

Vote For: 15 Against:0 Abstain:0

This will be ratified at the AGM

In addition the following ideas were discussed:

The idea of a Past President's fundraiser for club admin was suggested.

Interest was expressed about the club becoming a charitable trust, so that the subs we pay into club could be gift aided and the club would benefit by being able to reclaim the gift aid (For the increase proposed this would be 20% of £37.50 ie an additional income £7.50 per full member eligible.) Jane had made a presentation during her year as Regional President to encourage clubs to explore this. The Charities Commission offer a 'light touch' for charitable trusts with a low income, which does not require auditing of accounts, although there is a returns form to complete. Club members to consider this **ACTION: Presentation will be circulated for consideration. Jane/Claire**

Thanks to Joan for all the work in pulling the analysis of figures together.
