SIE Business Meeting held on 11th September 2019 at Edinburgh Central Youth Hostel

Present: Clephane (in the Chair) + 13 members. Clephane welcomed everyone to the meeting including visitor Kirsty, a 3S applicant.

Apologies for absence were received from 5 members: Christine, Gari, Trish, Carolyn, Morag.

SI Vision and Mission statement: was read by Dorothy.

3S: presentation from potential applicant:

Kirsty (pupil at James Gillespie High) has been invited to go to Chile for 1 year to teach English in San Diego (August 2020/2021). She also wishes to teach the girls football and act as a female role model to encourage their independence (Domestic violence is a significant issue in the area she will be visiting).

Kirsty is currently studying French and Maths and undertaking a crash course in Spanish. After school she wishes to do Languages and History at university. Kirsty coaches both trampolining and ice skating, plays the guitar with Edinburgh Guitar Ensemble, enjoys acting, has two jobs (to help fund her trip) and is a member of girlguiding (she was recently selected to represent them, working in Mexico for 10 days)

AGREED Club members recommended submission of application to the 3S fund.

News of members:

Gari: has travelled to India to support her pregnant daughter as her son-in-law has been diagnosed with Dengue Fever.

Morag: Clephane is planning to visit Morag.

Carolyn: reports are that she is feeling better but still not totally strong.

Margaret Thomson (died 23rd August 2019): Marjory reported on Margaret's recent funeral attended by a number of SIE members. It was recognised that SI Edinburgh had lost one of its most distinguished members and members stood for a minute's silence in Margaret's memory. (full report to be published in SIEnna). Obituary to appear in 'The Scotsman'. (post meeting note: Obituary to appear in October 2019 SIEnna)

ACTION: An item is to be sent to Soroptimist International.

Minutes of last business meeting held on 12th June 2019: These were unanimously accepted as an accurate record with the following amendments,

- 1) Donation to Meru project was £60 and not £52 as reported.
- 2) Clarification was provided that meetings in November and January will not be able to take place at the Youth Hostel (due to building work being undertaken)

Matters arising:

- Consideration needs to be given to an alternative venue for our November and January meetings. Approach to Croquet Club has been unsuccessful. Costs and availability are to be established for the following locations: Edinburgh University (Gari); Choir Vestry (Alison); St John's Church (Clephane); The Well, Nicholson Street (Clephane) **ACTION:** information to be obtained and discussed at next meeting.

- Clephane updated us re the opportunity for the club to sponsor a Christmas tree (at St Andrew's and St George's West church). We need to apply – Clephane will follow this up and report back.
- Great news re planting a tree at Saughton Gardens! The gardener wanted a tree for a certain spot in the gardens and thought of us. The tree has been ordered (Eriobotrya Japonica) at bargain price of £133. It is to be planted next to the Conservatory. Suggestion that we arranged to have tea/cakes there one afternoon/evening to mark the planting. It was agreed that a plaque near the tree would be appropriate. ACTION: discuss date of visit and wording on plaque at next business meeting.

Treasurer's report

Expenses when entertaining visitors: suggestion made by the Treasurer that the Club be responsible for any costs associated with entertaining visiting Soroptimists. (recently the cost was split between those SIE members who were able to attend the event and that felt unfair) AGREED.

Going forward any such expenses can be claimed from Myint Su (form available)

SYH meeting venue: we have agreed an adjustment from £75 per meeting to £65 due to renovations. Recommendation from Treasurer that we make an up-front payment for the year £700 (rather than pay each meeting) AGREED.

On-line banking: to set this up we required all signatories on the account to agree. This has been achieved however it has highlighted that the bank mandate is out of date with previous signatories not removed. Recommendation from Treasurer to update the mandate to reflect 4 signatories. AGREED. ACTION: Myint Su to arrange update of mandate and then apply for On-Line Banking.

Nationwide Account: Recommendation from Treasurer to move the funds from Nationwide (circa £6k) to RBS (similar interest rates received) to retain all monies in one financial organisation, easing access to funds and reducing multiplication of administration (eg mandates) ACTION : Myint Su to confirm interest rates being paid by RBS and Nationwide, and signatories required to facilitate transfer of fund. To be discussed at next business meeting.

SIGBI Conference

Voting for Secretary for Diamond Education Grant: Margaret Emsley is the only nomination. No objections from members in attendance. AGREED to support.

Decision on Club voting delegate: AGREED Anna Gordon. (Thanks Anna!)

Constitutional Resolutions:

Pat led us very ably through a discussion on the resolutions for conference, providing very useful and key information to aid understanding and ultimately a decision. Pat emphasised that there are significant changes being recommended which will alter the way SIGBI and associated Clubs will be managed/led/governed. It is critical that we all read as much as we can and understand the implications before guiding our voting delegate. ACTION: all to read

the Resolutions (and any additional information provided) and be ready to discuss our view at the next meeting on 25th September (it was agreed to dedicate some time at the start of the Speaker meeting for this important topic)

Specific Resolutions discussed

Resolution 6 – Capitation Fees: proposal to introduce an automatic increase in capitation each year linked to UK Consumer Price Index (capped at 4%) – ACTION : Pat to clarify if this increase relates to all clubs in Federation (Update 13/9/19 : it is to apply to ALL clubs not just UK based clubs) Concerns raised re 1) an automatic increase and thereby removing the opportunity for members to determine increase each year and 2) the financial impact on members of non UK clubs.

Resolution 1 – proposal to reduce the size of SIGBI Board from 13 Board Members to 6 Directors. (see Resolution for member make-up) Subsequent amendments received to 1) add ‘no more than 9 Directors’ and 2) recommend 7 Directors instead of 6 and splitting out Director of Finance & Governance into 2 roles Director of Finance and Director of Governance.

Pat flagged this as an example of the significance of the changes.

– Board members would become Directors of the Ltd Company – with significantly different (increased) responsibilities and accountabilities.

Directors would be supported by Standing Committees and Working Groups – made up of members with relevant expertise and experience to effectively advise the Directors. This could create more opportunity for grass roots members to get involved and influence top level decisions.

Resolution 5 – specifically impacts on the running of our Clubs.

There is a webinar for any member to attend and ask questions/ seek clarification. 26th September @ 7pm – to participate email hq@sigbi.org and they will provide details by Tuesday 24th.

Programme

Leaflet containing details of the Clubs Programme of activities for 2019/20 has been printed and is available for distribution. Further electronic/ hard copies are available from Myint Su. ACTION : Isabel to provide each member with a copy.

Scotland South Region

Myint Su confirmed that the Annual Report is now available on the website.

Membership: Region provided some hints and tips on membership, specifically it has proved most successful to induct new members within 1 or 2 meetings (no longer); members usually exit in the first 4 years, so try and keep them beyond that point; key message from potential members are to emphasise the opportunity to get involved in projects and the fun & friendship aspect.

Breast Cancer Prevention Scotland Celebrating 25 years

Thursday 19th September 2019

At Crowne Plaza, Royal Terrace, Edinburgh

Soroptimist International of Edinburgh members were invited to this fundraising event.

Five members were able to attend.

We were given a very warm welcome and invited to purchase raffle tickets and bid for some generous prizes. We were served with a glass of wine and juice with canopies.

The Charity has been renamed to emphasize its aims of ‘prevention’. There is very little focus on prevention from other cancer charities.

After an introduction from Gail, one of the four trustees, who became involved after her Aunt was diagnosed and successfully treated with Breast Cancer. Her Aunt is also a trustee.

There were two speakers Helen Lynn and Professor Annie Anderson who was from Dundee University specializing in what influences behavioural changes. Why is the diagnosis of Breast Cancer still rising?

Admittedly more people are surviving after breast cancer treatment. The causes of breast cancer are complicated. Only 5-10 per cent of breast cancers are due to genetics. 30 percent due to Lifestyle. The recent advertising from Cancer UK on obesity being a cause of cancer has caused some upset from the public. The speaker did mention that the increase in fat storage in the body and the increase in alcohol use were notable risks. Shift work is also a risk factor which may be due to light or at least the lack of light with nurses in particular, who do night shifts.
