## How SI Kenilworth & District ("we") use your information.

Your privacy is important to us. We are committed to safeguarding the privacy of your information.

## Why are we collecting your data?

We collect personal data to fulfil our role as a membership organisation, to monitor and assess the quality of our services, to fulfil our purposes and to comply with the law regarding data sharing. In legal terms this is called 'legitimate interests'. When it is required, we may also ask you for your consent to process your data. We do not share your information with others except as described in this notice.

## The purpose of the data

SI Kenilworth & District will use the data to run the Club for example to:

- Induct new members
- Prepare the Club's Annual Return to SIGBI
- Create a Club Directory so that we can contact each other when necessary
- Organise and publicise an event
- Fundraise
- Inform Club via the newsletter and meeting notes
- Promote the Club via social media including our website, Facebook and Twitter

## The categories of information that we may collect, hold and share include:

- Personal contact details (name, address, telephone number(s), email address)
- Date of joining, occupation
- Date of birth (shared with SIGBI for their membership statistics)
- Photos (if you prefer not to appear in a photo, please inform the photographer)
- Events in which Club members participate
- Archive material to commemorate activities and Presidential years

### **Storing your data**

We hold your data for varying lengths of time depending on the type of information in question but in doing so we always comply with Data Protection legislation. We will contact you annually to check that the information we are holding is accurate and that you agree to us holding it.

## Who do we share your information with?

We will not share your information with third parties without your consent unless the law requires us to do so.

We will share your data with SIGBI.

We will share your data with other Soroptimists

# Requesting access to your personal data
